We understand that we have been identified as stakeholders in your new initiative to develop domestic farmworker standards. Thank you for identifying us.

We do want to make sure the process of stakeholder engagement is clear and transparent. At this time, none of us has seen the details of this initiative including standards, compliance criteria, or implementation policies. Some of us have concerns about the direction this initiative may take.

At this time we are writing to ask you to first ensure that in any mention of our organizations as stakeholders, it is clear that we have not endorsed the program, supported the initiative, or even reviewed the details of what you are developing.

We would also like to be clear that our engagement in the stakeholder process needs to be meaningful. We would like to be sure that our concerns, if any, will be heard and addressed. Showing us your standards so that you may check stakeholder outreach off your list will not be sufficient.

We look forward to learning more about your domestic farmworker program and entering into a genuine dialogue.
